Thank you. However, you did not entirely answer my question. Is the photograph that was admitted into evidence as People's Exhibit 262 the same photograph that Mr. Bogdanos was referring to on page 4583 of the transcript when he stated at lines 15 to 22 the following:

"Next. Now let's put this photo up. Let's start normal. You know, this photo, this is a photo taken December 31st in the morning, right, 2009. Let's blow it up, please. Let's keep blowing it up. Let's keep blowing it up. Now stop. What is that? What's that wet stain? You look at other photos you see, much later, it's dry."

The transcript at page 4583 reflects that Mr. Bogdanos shows the jury People's Exhibit 262 at slide 72/212 and then shows the jury People's Exhibit 443 at slide 73/212. The next slide in the power point is slide 74/212. This slide is labeled as People's Exhibit 442-17 and is a surveillance camera photo of Ms. Covlin on her cell phone walking in the hallway of the building. Therefore, when in the above quote Mr. Bogdanos says "[n]ext. Now lets put this photo up. . ." he clearly cannot be referring to People's Exhibit 442-17 at slide 74/212. It appears that he is referring to Exhibit 262 (slide 72/212) a second time and stating that the photo was taken in the morning on December 31, 2009. However, the transcript at page 2293 and the People's exhibit list indicate that People's Exhibit 262 was taken by Detective Brown in the afternoon at 2:17 pm on December 31, 2009. If Mr. Bogdanos was not referring to People 's Exhibit 262 in the above quote, please inform me which Exhibit he is referring to.
